## **Chairman's Chatter**

August - a very busy month for the Club. The evening trial went well last Thursday, but once again heavy rain earlier in the day meant our numbers were down and we decided to forego the barbecue. A big thank you to Ben and Luke Edwards for turning out to lay out the reds and yellows, and for Pete J doing the blues. I had a crack at laying out the whites which seem to have been OK. Thanks also to Colin Don who appears to be mending and turned out to assist.

The next important day for the Club is the South Coast Group Trial at Beare Gill on August 14th. We need observers for this please; any volunteers should contact me. It is normal practice for club members to ride their own club trial only if all observers positions are filled or they have provided an observer. Normally at South Coast we manage reasonably well as there is a small group who attend each event just to observe - its paid! I am sure that's not the only reason but South Coast do pay their observers and we have decided to follow that practice so £15 is up for grabs on each section.

If you have ridden Beare Gill in the past you will know that the venue has improved over the last few years having had the benefit of some use and a few working parties. You may not know that up until now we have only used half the stream area available to us. The Southern half will be opened up for this trial offering some excellent sections and should be entertaining to observe. We haven't used this before because some areas require work to open them up. There will be a working party at the venue on Tuesday evening (9th) from approx 6pm if anyone is in a position to assist - bring pruners or saws if you have them and have stout footwear and gloves. Please note that there is still a hay crop in the fields - at all time keep to indicated routes and do not drive in the crop. Any competitors reading this please note that the venue will not be open for sections to be inspected during laying out on Saturday. We have a team to lay out and no more volunteers are required for that - thank you.

August is of course also the month of the camping weekend. The Committee meets this Wednesday to ensure all arrangements are in place. Jo Jenkins is working hard as always to ensure coordination of the event but has put us on notice that this is the last year that she wishes to be involved as main organiser. Jo will be a hard act to follow. If you enjoy the weekend and feel you may be able to put in some effort towards the running of it (although I do realise that many people attending the event are also involved in the running of it) please speak to Jo.

Debbie has been unable to get the newsletter out as she has been waiting for me to write this! But I am aware that she has not been swamped with articles. # South Coast Trial, Beare Gill, Ockley on Sunday 14 August 2011

We are holding our South Coast Trial at Beare Gill, Ockley on Sunday 14th August.

We are still looking for volunteers to observe on the day - £15 per section is up for grabs! We shall be clearing on Tuesday 9th August, and would welcome any help that could be given on that evening too - including bringing along tools to clear areas on the Southern side which we will be using for the first time. It offers the chance to make some challenging sections for the white & blue riders.

Please note that we have just discovered that the Olympic Trial Road Race (cycling) is taking place on the same day as our South Coast Trial and that the A25 and roads around Dorking will be closed. This should only impact anyone intending to travel from/via Dorking. Those heading from the South on the A24 should be unaffected.

Just as a reminder the venue is at Beare Green, near Ockley and will be signposted from the A29. Directions: If coming from the South on the A24 turn left onto the A29 (Bognor Road) at Beare Green roundabout. After approximately 1 mile heading west on the A29 there is a severe left hand bend with a road junction to the right in the middle of the bend. Turn right here into Henhurst Cross Lane (careful as it is a blind bend) and the venue is approximately 1 mile along this road on the left.

# **Camping Weekend**

### Ouch!

Having not ridden since February, (due to having a parachute course in April, and a cruise for our 25th Wedding Anniversary in June - and not wishing to have any injuries for either event!), I was really looking forward to the Club's evening trial at Beare Gill, Ockley in July.

You will recall that the weather had been filthy leading up to this event, but it had been decided to go ahead and run it anyway, albeit without the customary BBQ afterwards. The weather on the evening was actually quite good.

I started my first lap with enthusiam, and had some good rides, but I was obviously a bit rusty after my prolonged lay off.

On the last section of my first lap disaster occured - and it would have to be down at the stream! The route involved entering the stream followed by a tight left turn up a muddy bank about 4-5ft high. As I went up the bank I lost traction and slipped back towards the stream. I tried not to fall off but failed ending up in the stream on my bottom. I think I may have stuck my arm out in a futile attempt to stay dry!

I picked the bike up out of the stream and rode out of the section, marking a 5 on my punch card. At the time I thought I had aggravated the tendon in my elbow and carried on with the next lap. At the end of lap 2 my elbow was causing me some considerable discomfort and I decided to strap it up with duct tape - sometimes a compression bandage helps!

The duct tape enabled me to finish the trial, but my elbow was massive next morning after an uncomfortable night. X rays at A&E proved I have a radial head fracture. These days they do not put such fractures in a cast, so it is just grin & bear the pain, and do the exercises to try and maintain elbow mobility - ouch!

Hopefully I will be back riding soon - just not this side of September as I am hopefully parachuting again then. The wife says I should stick to parachuting - it's far safer!

# Serious Threat to our Sport - please take action!

The following is an extract from the LARA website - please read and take action asap to help save our sport:

The Government has published an *Issues Paper* which states that motor sport events (trials, moto-cross, etc.) give rise to 'significant concerns', and invites comments and views on changing the '14/28 Day Rule' under which most off-road sport is organised. Everyone involved in the Sport needs to reply to this consultation now.

Early in 2011 the Government announced a review of the 'Use Classes Order'. This order is a Statutory Instrument made under the provisions of Town and Country Planning legislation, and the review was stated to address the difficulties in changing the use of premises from (for example) business use to residential use. That has no bearing on land use for motor sport.

When the *Issues Paper* was announced to the press and then published for consultation (late June 2011) it became clear that the Government is looking beyond just the Use Classes

Order, and is also inviting comments on the General Permitted Development Order, which is the Statutory Instrument regulating temporary changes of use of land. The General Permitted Development Order (GPDO) is the basis of the '14/28 Day Rule', under which the great majority of car and motorcycle events in the countryside are operated.

Under the 14/28 Day Rule an event organiser does not have to apply for planning permission for the 'change of use' of the land, on the day of the event, from agricultural to motor sport. To have to so apply would be an enormous burden on clubs, farmers and planning authorities for no real benefit.

This *Issues Paper* is simply seeking comments, but it is the premise in the *Issues Paper*, that motor sport causes problems, that we have to tackle straight away.

This is what the Issues Paper says:

8. Are the current permitted development rights relating to the temporary use still appropriate?

If not, how do you think they should be amended?

- Permitted development also grants a general planning permission for the temporary use of land for up to 28 days in any calendar year, subject to a number of restrictions and conditions e.g. these provisions do not apply to the temporary use of buildings or to the use of land for advertisements. For some other uses, such as motor sports and markets, the permitted development rights are limited to not more than 14 days in total in the calendar year.
- These provisions can provide an important flexibility which enables many small-scale commercial and community activities, in both urban and rural areas, to go ahead without the cost and delay of obtaining planning permission. This benefits the local economy and, particularly in the case of activities on farm land, often constitutes an important source of revenue at the margins.
- However, we are aware that some temporary uses, for example, car boot sales and motor sports, even where they are operated for only for a relatively few days in the year, can give rise to significant concerns in some areas.
- The last review of these temporary use provisions took place almost 10 years ago.
  While this review found that the provisions remained appropriate and that no changes
  were required at that time, it would be helpful to know whether this remains the case
  or whether changes should be made to grant more or restrict freedoms for the temporary
  use of land.

### LARA's view

In 2002 our rigorous investigations found no well-founded 'significant concerns' arising from

properly run motor sport events, authorised by LARA Member Organisations. We have no evidence to suggest that this position has changed.

#### What does the Sport need to do now?

LARA is taking up the matter of the evidence that DCLG has regarding the alleged 'significant concerns'. In the meantime, the Issues Paper says:

23. We are not offering firm proposals for comment. Rather we want your thoughts and views on how change of use is currently handled through the planning system and areas for possible changes. A number of questions have been set out below to help focus responses and we would welcome your views on these in particular. We would also welcome more general views and evidence on issues that arise in respect of changes of use and the planning system, particularly any ideas on how the process of considering changes of use could be made less burdensome.

LARA's advice is that everyone who has an interest in off-road motor sport should make a response at this stage, stressing that Permitted Development Rights are essential to the continued running of a sport that now has over 100 years of tradition in the countryside, with over 5,000 events a year in England and Wales, which are run to strict safety and environmental rules, and which cause few if any problems. Simply, there is no evidence-based reason to change the current system.

Motor Club Chairmen (and anyone else) could usefully write to their own Member of Parliament (or go and see him or her) and ask their MP to take their concerns to the DCLG Minister responsible for this consultation: the Planning Minister, Mr Greg Clark (who is also the MP for Tunbridge Wells).
